#### **b)** South-West Wiltshire Council Area Board - Cllr Banas

- Cllr Nabil Najjar is now the chairman of the Area Board
- Capital grants will no longer be made to Parish Councils
- The PCC attend the last meeting. Working to increase police visibility. Wilshire police force is in special measures.

## c) <u>Climate Change</u> - Vacant

- Ms Boothman attended the meeting to talk about a proposed forming of a new group that would look for quick wins to bring down the parishes carbon footprint and have a positive impact on nature.
- The Village Hall could be used to host kids' activities linked to nature conservation.
- Would like to have a survey done by Wilshire Wildlife at a cost of £175

#### d) Footpaths / Rights of Way - Cllr Willis

Written report submitted:

- Have been engaging with local landowner Mr Dineley to flatten the nettles etc on his footpaths but so far to no avail. Thinking next year we might get a petrol driven scythe they start from around £900 through £2,000 and would enable metre wide footpaths to be cut along the parts where there's a real problem. The farmer who rents the fields above Middledean kindly did address the nettles and brambles there and cut a path through his crops.
- Two of the four new gates have been installed south of the A30 on Dineley land. They intend to insert a new pedestrian gate on SWAL 11 at the foot of the Downs, as with the old metal gate being so heavy and cumbersome it is often left open, allowing sheep from different breeding flocks to mix. Thanks to a visit from my sheep-farming cousin from Australia I am now on good terms with the shepherd. He explained that the old drove path (formerly a permissive footpath) at the foot of the Downs has been turned

- Visibility at some junctions has been an issue which have now been cut following request.
- The road surface from the church to West End isn't in the 5-year plan to be resurfaced, but the area highways engineer is campaigning for it to be. Chairman has requested support from the parishes Wilshire Councillor.
- The Vactor, a powerful gully cleaner is available if required.

### f) Heritage and Cultural Landscape (includes AONB) - Mrs Oborne

## g) South-West Wiltshire Community Safety Group - Cllr Banas

- Autospeed Watch is being trialled by Wilshire Police.
- 6 thefts locally from out buildings and one break in while the occupants were at home.

### h) <u>Local Planning & Development</u> - Cllr Blundell

The Clerk reported that the Tisbury, Station Road application (86 homes) is still being consulted upon. The developer has produced a report to show why they should not have to build any affordable housing; this now must be verified by Wilshire Council by doing its own report. Highways are yet to comment on the blocking of one arch proposal.

#### j) **Emergency Team**

- Still looking to organise some defibrillator training. Looking like that will be in Salsbury.
- The emergency plan should include a heat policy and older people in the community checked upon.
